

The project « TranslatEU » was funded with the support of the European Union under the Programme "Europe for Citizens"

Participation: The project involved 302 citizens, notably 74 participants from the city of Skopje (**FYRM**), 73 participants from the city of Brcko (**Bosnia and Hercegovina**), 31 participants from the city of Ljubljana (**Slovenia**), 5 participants from the city of Brussels (**Belgium**), and 119 participants from the Municipality of Vracar (**Belgrade, Serbia**).

Location/ Dates: The event took place in Vracar Municipality, (**Belgrade, Serbia**), from 09/12/2017 to 11/12/2017

Short description:

The day of 09/12/2017 was dedicated to Introduction of event and EU policies as well as Intercultural exchange among participants. Upon their arrival to Belgrade, first session was about introduction of the program and participants among themselves. Organizers share with them main ideas behind TranslatEU project and why it is important to bring closer EU values and EU citizenship to the young people. They also gone through the each of the topic of workshops which will take place tomorrow in order raise further their understanding and incite ideas. After that, they took active part in a country fair where each of the participating countries had their own corner to present country culture, tradition, life of youth or work of their organizations. By sharing among themselves presentations, promotional material, traditional gifts, food, music, this session contributed to their exploring of diversity.

The day of 10/12/2017 was dedicated to Press conference and thematic workshops Translating EU as well as municipality manifestation including fair, and all of the activities were open to all Vracar citizens. Press conference was dedicated to promotion of project and celebration of International Human Rights day. Representatives of Local Authorities and partners involved in project stressed importance of HR as starting value for building communities and promoting European Citizenship. They also stressed importance of this event for promotion of European values based on HR. With the aim of better understanding of EU and translation of its policies a large number of workshops with young people and citizens, which used their opportunity to contribute to workshops, took place within a project. Topics we covered were different, among others there were opportunities and rights which EU is offering in the field of ecology, culture, education, media, science, entrepreneurship, mobility and opportunities for volunteering. As a result of workshops a creative and interactive content was created, while discussion of all participants and citizens involved took place, debating on EU, its policies, challenges it face today, and how future of EU with Balkan countries in it can look like. Fair was organized also during this day and involved lot of citizens of Vracar. Meeting of local authorities took place at the end of the day, where all LA involved signed a Letter of intentions, which aim to empower cooperation among them.

The day of 11/12/2017 was dedicated to finalization of event and conclusions from workshops in order to find out how to improve advocating of EU policies in our societies, as well as of promoting of European citizenship, by having in mind Euroscepticism that exist in our societies. Also, announcing letter of understanding to public and PR activities in both traditional and online media outlets about project, took place.
